'Esther' ballet proves to be righteously good

Ballet Fantastique excels during a smooth and educational performance of an age-old biblical lesson

On Friday night at the Hult Center's Soreng Theater, Ballet Fantastique's "The Book of Esther," billed as "a rock gospel ballet," felt like a Bible lesson in 3-D.

Beautiful dancing, plus original music by the Gerry Rempel group and soulful singing by Andiel Brown and the UO Gospel Singers, told this age-old story.

The Book of Esther" is a part of the third section of the Hebrew Bible and also part of the Old Testament. It tells the story of a Jewish girl named Esther who is chosen by Xerxes to become Queen of Persia (modern Iran).

Esther thwarted a plan to commit genocide against her people.

The book is an integral part of the Jewish celebration of Purim, when the full text of "The Book of Esther" is read aloud, once in the evening and again the following morning.

Leanne Mizzoni is a tour de force as Esther. She is on stage practically the whole time, and her dancing is perfectly divine. Hannah Bontrager shadows Leanne as her spirit with beatific precision.

Justin Feimster is regal as King Xerxes. He has grown into a solid dancer with just the right nuance.

Guest artist Ernesto Lea Place, as King Xerxes' power-seeking Vizier, shows great technique in

both his solos and duets. Fellow guest artist Jim Ballard is Hegai, Keeper of the Women.

This is Lydia Rakov's first season with Ballet Fantastique, and we hope to see her more in the coming years. She rightly evokes sensuous cruelty in her role as Zeresh, wife to Haman.

Mother-and-daughter team Donna and Hannah Bontrager

have choreographed the whole ballet with equal eyes to classical technique and mirrors of ancient Persia.

That is especially true in the opening number, with Caitlin Christopher as Queen Vashti (who is replaced by King Xerxes with Esther), Ashley Bontrager as Princess Cassandane and Krislyn Wessel as Princess Amitis. The commissioned music "Procession and Fall of Vashti," written by Rempel, sets the tone for the rest of the ballet.

A surprise is the triple threat of Brown, artistic director of the UO Gospel Singers. Brown plays Mordecai, Esther's Uncle, who will not bow down to the king, and also sings, acts and dances. Brown is an excellent performer.

The 32-strong UO Gospel Singers wear black and stand

on black risers on stage left and right and become like a Greek chorus throughout the ballet. The award-winning chorus sings several traditional spirituals that flow delightfully through the performance.

Allison Ditson's costumes add much to the richness of the complete package. The enormous backdrop painting of Xerxes' palace keeps the ancient tone

All in all, it is a smooth and educational event.

of this ancient story.

From the teasers about the coming Ballet Fantastique season (its fifth at the Hult), we can look forward to more exciting works.

Logging rules altered after mudslide

Washington state will require logging firms to do geologic reviews before getting permits

SEATTLE - Timber companies that want to harvest near potentially dangerous landslide areas now will have to conduct geologic reviews before getting a logging permit from the state of Washington, officials said Friday.

Under the new stan-

dards announced by Commissioner of Public Lands Peter Goldmark, the state will require a geotechnical report when there's a potential risk to public safety – even if the harvest area itself doesn't include unstable territory.

"This added scrutiny provides more information to help properly identify potential hazards and avoid impacts," Goldmark said in a statement. The Department of

Natural Resources, or DNR, which Goldmark has led since 2009, approved logging in 2004 above the hill near Oso, Wash., that collapsed in March. The Seattle Times re-

ported in the wake of the mudslide that state officials had been relying on an outdated map to determine where loggers could harvest trees above the slide hill. A clear-cut

can increase groundwater flows and destabilize landslide-prone slopes.

Had state officials utilized a newer map at the landslide hill, regulators most likely would have restricted most of the 7.5 acres that were clear-cut in 2004. Goldmark's office said officials still are investigating the March landslide to determine if logging had any contributing role.

The March 22 slide killed at least 41 people.


