BIRTHDAY PARTY LIABILITY WAIVER/RELEASE

No child will be allowed to participate until this form has been signed by the parent or legal guardian. Every child attending must provide this signed form.

In consideration of participating in the Activity of Dance at Ballet Fantastique, I represent that I understand the nature of this Activity and certify that the undersigned is qualified, in good health, and in proper physical condition to participate in such Activity. I acknowledge that if I believe that conditions are unsafe, I will immediately discontinue the undersigned's participation in the Activity. I fully understand that like any physical Activity, Dance involves inherent risks of bodily injury, which may be caused by the participant's own actions or inactions, those of others participating in the event, the conditions in which the event takes place, or even the negligence of the "releesees" named below. I understand that there may be other risks either unknown to me or not readily foreseeable at this time, and I fully accept and assume such risks and responsibility for losses, cost, and damages I incur as a result of the undersigned's participation in the Activity. I hereby release, discharge, and covenant not to sue Ballet Fantastique, its respective administrators, directors, agents, officers, volunteers, and employees, other participants, any sponsors, advertisers, and owners and lessors of the premises on which the Activity takes place (each considered one of the "RELEASEES" herein) from all liability, demands, losses or damages, on my account caused or alleged to be caused in whole or in part by the negligence of the "releesees" or otherwise, including negligent rescue operations, and further agree that if, despite this release, waiver of liability, and assumption of risk, I, or anyone on my behalf, makes a claim against any of the Releasees, I will indemnify, save, and hold harmless each of the Releasees from any loss, liability, damage, or cost, which may incur as the result of such claim. I intend for this agreement to be a complete and unconditional release of all liability to the greatest extent allowed by law and agree that if any portion of this agreement is held to be invalid, the balance, notwithstanding, shall continue in full force and effect. I, the undersigned minor's parent and/or legal guardian, understand the nature of the above-referenced Activity—and the minor's experience and capabilities—and believe the minor to be qualified to participate in such Activity. I hereby release, discharge, covenant not to sue, and AGREE TO INDEMNIFY, SAVE & HOLD HARMLESS each of the releasees from all liability, claims, demands, losses or damages, on the minor's account caused or alleged to have been caused in whole or in part by the negligence of the releasees or otherwise, including negligent rescue operations, and further agree that if, despite this release, I, the minor, or anyone on the minor's behalf makes a claim against any of the above Releasees, I WILL INDEMNIFY, SAVE & HOLD HARMLESS each of the releasees from any litigation expenses, attorney fees, loss, liability, damage, or cost any releasees may incur as the result of such claim.
